## Memorial Day Parade - May 29

Barker American Legion Post 153, Park Ridge, is again sponsoring the annual Tri-Boro Memorial Day Parade on Monday, May 29th. Prior to the parade, there will be memorial services in each of the three towns at 9:00 AM. The parade will begin at 10:30 AM, rain or shine, leading off in Montvale, Memorial Drive, transit Park Ridge and terminate in Woodcliff Lake. (This is a permanent change from previous years alternating the starting point; Memorial Drive is a much safer location for assembly.) Jim Donovan is a past Commander of Post 153 who served during the Vietnam War as a Boatswain's Mate First Class with the United States Navy.



## Mayor's Message

I want to share the same information I have with you while everyone is contemplating the changes to our masterplan. When people react to wrong and incomplete information, and petition based completely on wrong fundamentals, it wastes everyone's time. I wish we didn't have to deal with this, like everyone, I wish they would just go away and leave us alone. But that's not going to happen and it is what we have to deal with. This is a mandate by the State Supreme Court and every town has the same issues. The two assembly bills by Assemblywoman Holly Schepisi are good will effort and I commend her for taking the initiative. We already passed a resolution in support of both bills. I wish I can say I am optimistic but knowing the landscape, I am not and this is shared by the majority of leaders and professionals I spoke with.

We are going to be hiring a professional marketing person to help us market Montvale. We are looking to purchase one or more parcels of land and we have our Chamber of Commerce and the Economic Development Committee actively working to find new corporations to move in.

All of the Borough officials are working as hard as possible to maintain the character of our town, while we diligently attempt to meet the court's demands and provide our fair share constitutionally-required affordable housing. With that said, we, along with our professionals and the Court-Appointed Master, have brainstormed, investigated and evaluated the various options that are available to us.

As a practical matter, we can't buy out vacant buildings and leave them as open space, with a price tag for the current four vacant corporate buildings over \$55 million. In addition, a loss of \$2 million a year in tax revenue would have a huge negative impact on our property taxes. Not only that, buying up vacant land won't decrease our affordable housing obligations by a single unit. If anything, it would signal to the Court that the Borough is trying to artificially reduce its obligations, and we will instantly become a target for developers and Fair Share Housing Center.

It also would not be advisable to ignore our obligation in the short-term, drag out the process and let the Courts decide on how many units to assign to Montvale. In that scenario, the uncertainty surrounding Montvale's obligation would remain, and we would face the possibility of a higher obligation than we might otherwise be able to settle for now with Fair Share Housing Center and the Court. This advice was provided to us directly by the Court Appointed Master.

Refusing to address the issue and challenging the entire process in Court will be expensive, fraught with uncertainty, and, looking at recent history, ultimately unsuccessful. We would almost immediately lose our current immunity from builder's remedy lawsuits. In the end, we would likely lose all control over our local zoning and end up with a Court-Appointed Master approving all zoning amendments and approvals in Montvale. That would mean that one individual could control the type, location, density, and all other aspects of all development in Montvale.

So, as you see, we have limited options and the best option is for us to be proactive and plan our own town the way that is best for us. We have four vacant buildings that the Master has identified as candidates for redevelopment. Redevelopment of some combination of the Mercedes buildings, A&P, Mack-Cali and Sony could potentially satisfy 75% of our affordable housing obligations, while adding about 600 residential units in a mix of condos, town houses and high-end apartments. We also have a rezoning planned for 110 Summit to permit the development of an assisted living facility that will also help satisfy our obligation, as well as a few other smaller projects that we expect will yield additional COAH credits. Our school officials have assured us that they have room to grow and can take on more students, although the developments being discussed should not add a significant number of school-aged children.

It is our hope that with your input and support, we can guide the development process to preserve the best parts of the Borough's corporate zones while satisfying our constitutional affordable housing obligations. As always, I will make myself available to any resident who wishes to discuss these matters in more detail.

# Police Department

Hello Montvale,

It is our intention to keep the public as informed as possible, particularly in emergency situations. We utilize Facebook (montvalepd), Twitter (@MontvalePD), and the Swift911 service. If you are not signed up for Swift911, go to Montvale.org website and the swift 911 sign-up tab is on the lower left part of the screen or go directly to [www.bcoem.org](http://www.bcoem.org) to sign up. At the bottom of the page there is a registration button to sign up for local and countywide emergency alerts. You can receive the messages by email, text or phone calls.

Another ongoing challenge in policing suburban communities is dealing with vehicles exceeding the speed limit, especially in residential neighborhoods. I frequently receive complaints about "speeders" on streets all over town. Some of the streets that are more prone to problems than others include North Ave., Magnolia Ave., Woodland Rd., Bayberry Dr., Spring Valley Rd., Akers Ave., Terkuile Rd., Hilton Pl., Sunrise Dr., and Main St. When we target an area with extra radar patrols it becomes apparent that the majority of the speed violators are not transient motorists, but Montvale residents and Montvale corporate residents. If you are reading this then you probably drive those roads. Some of these streets are in school zones. Speeding in an area where children are likely to be walking/biking/playing is simply irresponsible. Please be courteous of your neighbors and obey the posted speed limits.

May is Bicycle Safety Month.

As a reminder, in New Jersey, anyone under 17 years of age that rides a bicycle or is a passenger on a bicycle, or is towed as a passenger by a bicycle must wear a safety helmet. The law includes roller skates, in line skates and skateboards.

In New Jersey, the law states a bicyclist must obey all state and local automobile driving laws. A parent may be held responsible for the child's violation of any traffic law.

Make sure that the bicycle is properly maintained and fitted for the rider. Be extra vigilant with tire pressure, seat height, and brakes.

## Construction Department

As many residents may be aware, the issue of a tree removal ordinance has been discussed for many years. There are certainly arguments for and against such an ordinance. But in the absence of any such ordinance, my office continues to come across problems, miscommunications, and unforeseen expenses that negatively impact the property owner.

In an effort to assist property owners and eliminate these problems, my department will be requiring, effective immediately, a Tree Removal Review form to be submitted to the building department as part of the building application file. This will apply to additions, exterior alterations, decks, patios, and general site cleanup & clearing.

This review form is available online at the borough website. It is NOT a permit and there is no fee for this review. The purpose is to allow the building department to conduct a review of proposed tree removal and alert the homeowner of any additional expenses they may incur due to the removal of tree(s). The removal of large trees or a large number of small trees and the associated stumps can result in extensive soil disturbance which may trigger the need for a soil conservation permit from the county, an engineered regrading plan, a soil movement permit from the borough, or all of these. This can translate into additional costs and project delays to the property owner.



We know very well how unanticipated expenses can impact a project and this is one way we can provide assistance to the property owner and improve the lines of communication from our office. As we get into the warmer weather, we will begin to see an increase in the number of permits for exterior work. This will give us almost all of 2017 to assess the effectiveness of the review program and make any changes that may be needed. We appreciate your cooperation and feedback, good or bad.
