## 2022 NON LIFE HAZARD BUSINESS/ORGANIZATION REGISTRATION

The Montvale Fire Prevention Bureau has been designated the local enforcement agency to implement the provisions of the New Jersey State Uniform Fire Code. The Code provides for the adoption of a fee schedule to cover the cost of annual fire prevention inspections in addition to administrative fees, penalties and fines to violators.

Your annual registration form is enclosed. Please complete the form in full and return along with a check made payable to the Borough of Montvale Fire Prevention Bureau within 30 days of receipt.

Your registration fee is based on the total square footage of all floors and suites which comprises your occupancy. Each individual building/suite or common area is to be registered separately, i.e. three buildings are three separate registrations. Please note the following Non Life Hazard fee schedule applicable at this time.

### 2019 Fee Schedule

Fee Code	Amount	Description
U1	\$65.00	Non Life Hazard Use - Up to 1,000 square feet in area
U1-A	\$115.00	Non Life Hazard Use - 1,001 to 2,500 square feet in area
U2	\$185.00	Non Life Hazard Use - 2,501 to 5,000 square feet in area
U3	\$365.00	Non Life Hazard Use - 5,001 to 10,000 square feet in area
U4	\$730.00	Non Life Hazard Use - 10,001 to 50,000 square feet in area
U5	\$1,025.00	Non Life Hazard Use - 50,001 to 100,000 square feet in area
U6	\$1,400.00	Non Life Hazard Use - 100,001 to 200,000 square feet in area
U7	\$2,050.00	Non Life Hazard Use - 200,001 to 250,000 square feet in area
U8	\$2,670.00	Non Life Hazard Use - 250,001 square feet in area and over
