### **New Business:**

- Tree Removal Permit Request 30 Spring Valley Road, Block 202, Lot 12
  - Review of application has been postponed until we received the necessary information completed/submitted on the application.
- Tree City Signage
  - o Mayor and Council has approved funding for additional signage in town.
  - o R. Hanrahan presented the location options to the Mayor and Council and the idea was well received.
  - o All in agreement that we should promote Montvale's Tree City status.
  - Potential locations for signage: North and South on Kinderkamack Road, East and West on Grand Avenue, the Red Shed and North and South on Chestnut Ridge Road.

- o R. Hanrahan requested recommendations on other signage options from the EC members.
- R. Hanrahan requests the EC to form a subcommittee and work together to finalize the details on implementing the signage.
  - R. Preston volunteers to participate.
  - Details to include locations, research on costs and additions/verbiage to the signs.
  - R. Zitelli has some detailed information on required heights and locations.
  - Please let, Bob, Ellen or Randy know if you would like to assist.
- Communication about Tree Ordinance to New Families
  - o R. Hanrahan is modifying the trifold pamphlet on trees to highlight the tree ordinance.
  - o R. Hanrahan is writing an article on wetlands and category 1 waterways.
  - o Suggestion to include a cover letter from the EC or from Mayor and Council.
  - o Suggestion to include information on recycling.

### **Old Business:**

- Community Project Update (Lisa De Pellegrini)
  - o Update on Bat Education Project (Lisa De Pellegrini)
  - o L. DePellegrini has disassembled 6 palates for use on the bat house project.
- Pascack Trail/Huff Pond Update (Robert Hanrahan)
  - o R. Hanrahan is communicating with the DEP about options to stabilize the soil around the work that was down at Huff Pond.
  - o R. Hanrahan reached out to Congressman Gottheimer who is working on the Park Ridge waterway. Would like to request his assistance in escalating the DEP work.
- Montvale Plastic Bag Recycling Update (Randy Preston/Mairead Jensen)
  - o Volume of plastic bags being deposited is decreasing.
  - o R. Preston and M. Jensen will meet on Wednesday to evaluate our progress.
  - We just started another six week challenge with Trex.
  - o By the conclusion of March we have collected 4986 pounds or approximately 411,000 plastic bags.
- Electric Vehicle Update (Lisa Skoglund/Antonio Vozzolo)
  - o A. Vozzolo requests an inventory of borough owned vehicles to facilitate research.
- Community Garden Update (Robert Hanrahan)
  - o No new information to report.
- Open Spaces and Recreation Plan (Mairead Jensen/Robert Hanrahan)
  - o Barbara Davis reached out to R. Hanrahan for dates to meet with the Mayor and Council, Planning Board and the Environmental Commission.
- Bicycle and Walking Plan (Antonio Vozzolo)
  - o Only one person working as a liaison at DOT to communicate with towns and requests.
