NOTICE IS HEREBY GIVEN that the following Ordinance was introduced and passed on the first reading at the regular meeting of the Mayor and Council on the 26th day of April 2016, and that said Ordinance will be taken up for further consideration for final passage at a regular meeting of the Mayor and Council to be held on the 10th day of May 2016 at 7:30 pm or as soon thereafter as said matter can be reached, at which time and place all persons who may be interested therein will be given an opportunity to be heard concerning same.

BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE BOROUGH OF MONTVALE, IN THE COUNTY OF BERGEN, NEW JERSEY, APPROPRIATING \$1,500,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$1,425,000 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF MONTVALE, IN THE COUNTY OF BERGEN, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The several improvements described in Section 3 of this bond ordinance are hereby respectively authorized to be undertaken by the Borough of Montvale, in the County of Bergen, New Jersey (the "Borough") as general improvements. For the several improvements or purposes described in Section 3, there are hereby appropriated the respective sums of money therein stated as the appropriation made for each improvement or purpose, such sums amounting in the aggregate to \$1,500,000, and further including the aggregate sum of \$75,000 as the several down payments for the improvements or purposes required by the Local Bond Law. The down payments have been made available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 2. In order to finance the cost of the several improvements or purposes not covered by application of the several down payments, negotiable bonds are hereby authorized to be issued in the principal amount of \$1,425,000 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. The several improvements hereby authorized and the several purposes for which the bonds are to be issued, the estimated cost of each improvement and the appropriation therefor, the estimated maximum amount of bonds or notes to be issued for each improvement and the period of usefulness of each improvement are as follows:

Estimated Maximum Appropriation & Amount of Bonds Period of Estimated Cost Purpose & Notes Usefulness \$300.000 10 years Improvements to various \$285.000 roads including curbing as listed on file in the office of the Clerk, including all work and materials necessary therefor and incidental thereto.

Eagle Ridge Sanitary Sewer System improvements, including all work and materials necessary therefor and incidental thereto.	\$550,000	\$522,500	40 years
Improvements to various buildings and public grounds, including all work and materials necessary therefor and incidental thereto.	\$650,000	\$617,500	15 years

The excess of the appropriation made for each of the improvements or purposes aforesaid over the estimated maximum amount of bonds or notes to be issued therefor, as above stated, is the amount of the down payment for each purpose.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no bond anticipation note shall mature later than one year from its date. The bond anticipation notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with bond anticipation notes issued pursuant to this bond ordinance, and the chief financial officer's signature upon the bond anticipation notes shall be conclusive evidence as to all such determinations. All bond anticipation notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law. The chief financial officer is hereby authorized to sell part or all of the bond anticipation notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the bond anticipation notes pursuant to this bond ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the bond anticipation notes sold, the price obtained and the name of the purchaser.

Section 5. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

(a) The improvements or purposes described in Section 3 of this bond ordinance are not current expenses. They are all improvements or purposes that the Borough may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.

(b) The average period of usefulness, computed on the basis of the respective amounts of obligations authorized for each purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 23.16 years.

(c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$1,425,000, and the obligations authorized herein will be within all debt limitations prescribed by that Law.

(d) An aggregate amount not exceeding \$500,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purposes or improvements.

Section 7. The Borough hereby declares the intent of the Borough to issue bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use the proceeds to pay or reimburse expenditures for the costs of the purposes or improvements described in Section 3 of this bond ordinance. This Section 7 is a declaration of intent within the meaning and for purposes of Treasury Regulations.

Section 8. Any grant moneys received for the purposes or improvements described in Section 3 hereof shall be applied either to direct payment of the cost of the improvements or to payment of the obligations issued pursuant to this bond ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 9. The chief financial officer of the Borough is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Borough and to execute such disclosure document on behalf of the Borough. The chief financial officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Borough fails to comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

Section 10. The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Borough for the payment of the obligations and the interest thereon without limitation of rate or amount.

Section 11. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

WHEREAS, a portion of Main Street located in or around the property known as 59 Main Street has had issues with flooding over the past few years; and

WHEREAS, as part of the 2015 Montvale Road Program, and at the recommendation of the contractor hired for the Road Program, it has been determined by the Borough Engineer that the most efficient and cost-effective method of controlling drainage issues at the location in question would be the installation of an underground detention basin that connected to a municipal storm drain and associated drainage controls (the "Drainage System") partly located on the property identified as Block 707, Lot 4 in the Borough of Montvale, also known as 59 Main Street, owned by Anthony and Janet Russo (the "Property Owners"); and

WHEREAS, the Drainage System will be owned, operated and maintained by the Borough of Montvale; and

WHEREAS, the Property Owners are amenable to the Borough's installation of the Drainage System at the Borough's expense and are willing to grant to the Borough of Montvale all necessary and appropriate easements and other permission in order for the Borough to install, access and maintain the Drainage System; and

WHEREAS, the Borough Attorney has prepared appropriate documents pertaining to same based upon information submitted by the Borough Engineer; and

WHEREAS, upon approval and execution of these documents by the Property Owners, these documents must be formally accepted by the Borough of Montvale pursuant to the Local Lands and Buildings Law. *N.J.S.A.* 40A:12-1, et seq.; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Montvale, County of Bergen, State of New Jersey as follows:

- Pursuant to the Local Land and Buildings Law, N.J.S.A. 40A:12-1 et seq., the Borough of Montvale hereby accepts from Anthony and Janet Russo, owners of 59 Main Street, Montvale, New Jersey, 07645, the easements described herein and attached hereto, which are expressly made a part hereof.
- 2. The Mayor, Borough Clerk and all other appropriate officials are hereby authorized and empowered to execute all documents and take all steps necessary to effectuate the purposes of this Ordinance.
- 3. The Borough Attorney shall file a copy of all easement documents with the County Clerk, as required by law.
- 4. This Ordinance shall take effect immediately upon adoption and publication as required by law.

PUBLIC HEARING ORDINANCE NO. 2016-1411 AN ORDINANCE OF THE BOROUGH OF MONTVALE, COUNTY OF BERGEN, AMENDING AND SUPPLEMENTING CHAPTER 106 OF THE BOROUGH CODE IN ORDER TO ESTABLISH A "NO-KNOCK LIST"

BE IT ORDAINED by the Mayor and Council of the Borough of Montvale as follows: <u>Section 1</u>. Chapter 106 of the Borough Code is hereby amended and supplemented by adding a new Section 106-10, "No-Knock List," as follows:

§106-10 No-Knock List.

- A. <u>Establishment of No-Knock List</u>. All residents of the Borough may register their name, address and/or unit/apartment number with the Municipal Clerk to be placed on the No-Knock List, indicating that they do not want canvassers, distributors, solicitors, peddlers, transient merchant or hawkers of any sort to approach their homes and/or seek personal contact with the occupants of the registered residence. The Municipal Clerk shall provide the registration form, which shall be available during normal business hours. By registering for the No-Knock List, the resident acknowledges that the Borough Police, Fire and other Emergency Services groups are exempt from the requirements of this section.
- B. <u>Updating and provision of list</u>. The Municipal Clerk shall maintain a No-Knock List, a copy of which shall be provided to all persons or organizations required to obtain a license or register pursuant to this Chapter. Registrants shall remain on the No-Knock List for a period of five (5) years from the date of registration, or until such time as they advise the
- C. Municipal Clerk in writing that they wish to be removed from the list. The Municipal Clerk shall ensure that the list is updated periodically.
- D. <u>Registration and display of decal</u>. Upon completion of registration on the No-Knock List, the subscriber may purchase and receive, for a fee of \$1.00, a decal stating "DO NOT KNOCK; Registered on the No-Knock List with the Borough of Montvale Municipal Clerk; VIOLATORS WILL BE PROSECUTED", which may be displayed in a clearly-visible location (e.g., front door or window adjacent to the front door).

E. <u>Violations</u>. It shall be unlawful for any canvasser, distributor, solicitor, peddler, transient merchant or hawker to approach and/or seek personal contact with the occupants of any residence if that residence is registered on the No-Knock List. Anyone violating this subsection shall, upon conviction thereof, be subject to fines and penalties in accordance with Chapter 1, Article II, General Penalty" of the Borough Code.

Section 2. Severability.

If any provision or portion of a provision of this ordinance is held to be unconstitutional, preempted by Federal or State law, or otherwise invalid by any court of competent jurisdiction, the remaining provisions of the ordinance shall not be invalidated and shall remain in full force and effect. <u>Section 3</u>. Effective date.

This Ordinance shall take effect thirty (30) days after final adoption and publication required by law, or at such time as the Municipal Clerk advises the Mayor and Council in writing that the registration forms and decals are available at the Municipal Clerk's office, whichever last occurs. <u>Section 4</u>. Repeal of inconsistent ordinances.

All ordinances and parts of ordinances which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

RE: RESOLUTION IN SUPPORT TO DENY PAROLE FOR CHRISTOPHER RIGHETTI

WHEREAS, on August 31, 1976, Kim Montelaro, a resident of New Milford, Bergen County, then 20 years old, was forcibly abducted, brutally assaulted and murdered by repeat offender, Christopher Righetti; and

WHEREAS, Christopher Righetti, Prisoner #59431, is currently incarcerated for the killing of Kim Montelaro; and

WHEREAS, Christopher Righetti has gone many times before the Parole Board of Northern State Prison. His release was denied each time, as the parole board found that Christopher Righetti was unwilling to take responsibility for abducting, assaulting and murdering Kim Montelaro;

WHEREAS, Christopher Righetti has never shown any remorse for his crime and has made no substantial progress in addressing the issues that led him to murder Kim Montelaro and has demonstrated a substantial risk for recidivism; and

WHEREAS, Kim's family should not be made to relive this horrible crime every few years when there is a parole hearing. They are forced to travel long distances from their current residence in Florida each time there is a parole hearing for their daughter's killer. They continue to suffer unnecessarily on Christopher Righetti's account; and

WHEREAS, in addition to the efforts of the Montelaro Family, the Borough of Maywood hereby supports the position that Christopher Righetti should not be granted parole and should serve out the full remainder of his life sentence. If a future eligibility date is set, we urge the Board to select a date at least 35 years from now. The abduction, rape and murder of an innocent young woman is a serious crime that demands justice; and the family of Kim Montelaro should be given the peace of mind of knowing that their daughter's murderer will remain behind bars for the rest of his life, as ordered by the court.

NOW, THEREFORE, BE IT RESOLVED, that the Borough of Montvale hereby abides by the conclusion that Christopher Righetti be denied parole and be made to serve out his life sentence, otherwise this creates a grave injustice to the family of Kim Montelaro as well as to society.



The bid opening for the above-referenced project was held on Friday April 29, 2016 at 11:00 a.m. in the Council Chambers with the Municipal Clerk/Administrator Maureen Iarossi-Alwan in attendance. There were five (5) bids received for the project, which included a Base Bid and Alternate Bid 'A'. The Base Bid was for the Eagle Ridge Road Sanitary Sewer Extension, and Alternate Bid 'A' was for roadway milling and paving.

Your Way Construction, Inc., 404 Coit Street, Irvington, New Jersey is the apparent low bidder for the Base-Bid Sanitary Sewer Construction and appears to have submitted all necessary documents as required by the specifications. The Borough Attorney has indicated that the submitted bid appears to be responsive to the bid specifications. After analyzing the five (5) bids received, this office recommends the award of only the Base Bid for this project in the amount of \$356,490.44 to Your Way Construction, Inc.

This office conducted a review of the three (3) lowest bidders and has attached our Bid Tabulation based on the items contained in our bid specifications and the bid proposal by the contractors. We should note that while the extended price in each line item of the proposal from Your Way Construction Inc. is correct, the Base Bid total was listed as \$356,491.04, while the correct amount is \$356,490.44 (a difference of \$0.60).

Please also note that the schedule for the work under the FEMA Grant requires that the work be completed no later than August 31, 2016. Due to this schedule and the likelihood of settlement of the roadway following construction, our office recommends that the milling and paving of the affected streets should wait until later in the year, under a separate contract.

Our recommendation is subject to the approval of bid documents by the Mayor and Council and certification of funds by the Borough.



RE: A Resolution Requesting That the Planning Board Conduct of Investigation Into Whether Block 2702, Lot 1 and Block 2801, Lot 2 (also known as 1 and 3 Mercedes Drive) and Block 3201, Lot 6 (also known as 1 Glenview Road) Should Be Designated as an "Area in Need of Redevelopment" Pursuant to the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq.

WHEREAS, Block 2702, Lot 1 and Block 2801, Lot 2 (also known as 1 and 3 Mercedes Drive) and Block 3201, Lot 6 (also known as 1 Glenview Road) (collectively, the "Mercedes Properties") are currently owned by Mercedes Benz and/or its subsidiaries Mercedes Benz of North America, Inc. and Mercedes Benz USA, Inc.; and

WHEREAS, Mercedes has already vacated 1 Mercedes Drive and has indicated that it intends to vacate the remaining Mercedes Properties as it moves its operations to its new facility outside of Atlanta, Georgia, leaving three large vacant corporate facilities with no immediate prospect for office use or commercial occupancy; and

WHEREAS, the Governing Body believes it is in the best interest of the Borough that the Planning Board conduct an investigation with respect to the Mercedes Properties to determine whether the Mercedes Properties meet the criteria set forth in the *LRHL*, specifically *N.J.S.A.* 40A:12A-5, to be designated as an area in need of redevelopment (non-condemnation).

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Montvale as follows:

<u>Section 1</u>. The foregoing recitals are incorporated herein as if set forth in full.

Section 2. The Montvale Planning Board is hereby authorized and directed to conduct the necessary preliminary investigation, including the holding of a public hearing, to determine whether the study area consisting of Block 2702, Lot 1 and Block 2801, Lot 2 and Block 3201, Lot 6 (the "Study Area") is or is not an area in need of redevelopment (non-condemnation) under the criteria set forth in the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1, et seq.

<u>Section 3.</u> As part of its investigation, the Planning Board shall prepare a map showing the boundaries of the Study Area and the location of the parcels contained therein, and appended thereto shall be a statement setting forth the basis of the investigation. A copy of the map shall be maintained on file with the office of the Borough Clerk.

<u>Section 4.</u> The Planning Board shall conduct a public hearing in accordance with the *Local Redevelopment and Housing Law*, specifically *N.J.S.A.* 40A:12A-6, after giving due notice of the proposed boundaries of the Study Area and the date of the hearing to any persons who are interested in or would be affected by a determination that the Study Area is an area in need of redevelopment. The notice of the hearing shall specifically state that the redevelopment area determination shall not authorize the Borough to exercise the power of eminent domain to acquire any property in the delineated area, for the Study Area is being investigated as a possible Non-Condemnation Redevelopment Area.

<u>Section 5.</u> At the public hearing, the Planning Board shall hear from all persons who are interested in or would be affected by a determination that the Study Area is a redevelopment area. All objections to a determination that the Study Area is an area in need of redevelopment and evidence in support of those objections shall be received and considered by the Planning Board and made part of the public record.

<u>Section 6.</u> After conducting its investigation, preparing a map of the Study Area, and conducting a public hearing at which all objections to the designation are received and considered, the Planning Board shall make a recommendation to the Mayor and Council as to whether the Mayor and Council should designate all or some of the Study Area as an area in need of redevelopment.

<u>Section 7</u>. This Resolution shall take effect immediately.

ORDINANCE NO. 2016-____

AN ORDINANCE OF THE BOROUGH OF MONTVALE, COUNTY OF BERGEN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 95 OF THE BOROUGH CODE IN ORDER TO ADD REGULATIONS CONCERNING GREASE TRAPS

WHEREAS, pursuant to Borough Code § 52-2, it is prohibited to discharge into the Borough sewer system all "fluid wastes which contain in excess of 100 parts per million of fat, oil or grease, either vegetable or mineral"; and

WHEREAS, in order to better enforce this existing restriction, the Borough is desirous of adopting an Ordinance to mandate the installation of grease traps or interceptors in certain establishments and to provide regulations concerning same.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Montvale, County of Bergen, State of New Jersey, as follows:

<u>Section 1</u>. Chapter 95 of the Borough Code, entitled "Sanitation and Plumbing," is hereby amended and supplemented by adding a new Article XVI, entitled "Grease Traps and Interceptors," as follows:

Article XVI

Grease Traps and Interceptors

- §95-118 Grease traps and interceptors required; specifications.
- **§95-119** Maintenance and inspections.
- §95-120 Violations and penalties.

§95-118 Grease traps and interceptors required; specifications.

All food service establishments shall be required to install a grease trap or interceptor. All other commercial and/or industrial establishments shall be required to install a grease trap or interceptor when, in the reasonable opinion of the Plumbing Subcode Official, grease, flammable waste, oil and sand interceptors or oil reclaimers are necessary due to the type of activity/use of the property. The following regulations and requirements shall apply to all grease traps and interceptors where such grease traps or interceptors are installed or required to be installed:

- A. No grease trap or interceptor required by this Article shall be installed, modified, or removed from a building or premises without a permit approved by the Plumbing Subcode Official.
- B. All interceptors and traps shall be installed, and shall be of a type and capacity, in accordance with the Plumbing Subcode adopted by the Commissioner of Community Affairs as set forth in the New Jersey Uniform Construction Code 5:23, Subchapter 3.15, Plumbing Subcode.
- C. Failure to properly maintain an installed grease trap or interceptor shall be a violation of this Article and shall be subject to the penalty provisions set forth herein. In addition to any penalties imposed for a violation of this Article, the following costs shall also be imposed for any violation:
 - 1. The costs for clearing and cleaning any blockages in the sanitary sewer mains that are attributable to the establishment/property. Such charges shall include, but are not limited to, the full cost for labor, including fringe benefits, equipment costs, and surcharges, if any, whether those costs were incurred by Borough employees or by a contractor hired by the Borough, or both.
 - 2. All property damage arising out of a sewer blockage caused by the establishment shall also be borne by the owner of the establishment/property causing the blockage.

§95-119 Maintenance and inspections.

- A. All grease traps and interceptors shall be maintained by the owner, at the owner's expense, in continuous, efficient operation at all times.
- B. All grease traps and interceptors shall be inspected and cleaned at the owner's expense no less often than once every six (6) months. All grease and other waste shall be properly stored and disposed of so as not to create a nuisance or threaten the public health and welfare. The Board of Health and the Superintendent of the Department of Public Works, or their respective designees, shall have the authority to require inspections more frequently if in their discretion such inspections are necessary to protect the public health and welfare. The owner shall be notified in writing of any change in inspection schedule.
- C. Proof of all mandatory periodic inspections and cleaning from a licensed countyregistered grease and waste disposal company or qualified recycling company shall be provided to the Board of Health on a form provided by the Borough within ten (10) days of each inspection.
- D. All establishments shall maintain copies of all forms evidencing proof of inspection. Copies of all proof of inspection forms shall be posted as close as

possible to the grease trap or interceptor to which it applies. The forms shall be protected from soiling.

- E. The Board of Health shall require all grease traps and interceptors to be efficient in operation and may, at the expense of the owner, require independent laboratory tests to ascertain the concentration of grease being emitted from the effluent line of the unit.
- F. The Borough of Montvale, the Board of Health, the Department of Public Works and their respective officers, officials and employees shall be held harmless from any and all damage or injuries of any kind that may occur during or as the result of any inspection conducted pursuant to this Article.

§95-120 Violations and penalties.

- A. Any person, company or corporation who shall violate any of the provisions of this Article shall, on a first offense, be subject to a thirty-day notice to comply with this Article.
- B. A second or subsequent offense of any of the provisions of this article shall, upon conviction thereof, be subject to fines and penalties in accordance with Chapter 1, Article II, "General Penalty" of the Borough Code.
- C. A separate offense may be deemed committed on each day during or on which a violation occurs or continues.

Section 2. Severability.

If any provision or portion of a provision of this ordinance is held to be unconstitutional, preempted by Federal or State law, or otherwise invalid by any court of competent jurisdiction, the remaining provisions of the ordinance shall not be invalidated and shall remain in full force and effect.

Section 3. Effective date.

This Ordinance shall take effect ninety (90) days after final adoption and publication required by law.

Section 4. Repeal of inconsistent ordinances.

All ordinances and parts of ordinances which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

Chapter 90B. Recreation Article I. Recreation Director § 90B-1. Creation of position.

The position of Recreation Director in the Borough of Montvale is hereby created.

§ 90B-2. Appointment; term; removal from office.

- A. The Recreation Director shall be appointed annually by the Mayor and Council.
- B. Unless removed in accordance with this section, the term of the Recreation Director shall be one year.
- C. Notwithstanding the foregoing, the Recreation Director shall serve at the pleasure of the Mayor and Council.

§90B-3. Compensation.

The salary of the Recreation Director shall be as set forth in the Borough's Salary Ordinance.

§ 90B-4. Qualifications; residence.

The Director of Recreation shall be trained and thoroughly versed in modern recreation theory and practice. The Recreation Director need not be a resident of the Borough.

§ 90B-5. Powers, duties and responsibilities.

The Recreation Director shall be under the direct supervision and control of the Borough Administrator, subject to the oversight of the Mayor and Council. The Recreation Director shall have such powers and responsibilities and shall perform such duties as, but not limited to, the following:

- A. Administering, planning, supervising and conducting programs and activities of the Borough's public playgrounds, athletic fields, recreation centers and other recreational facilities and any of
- the properties owned and controlled by the Borough, including, but not limited to, recreational programs, cultural activities, youth programs and the summer camp, in conjunction with the Recreation Committee, subject to formal approval by the Mayor and Council.

Β.

- C. Planning and promoting the immediate and long-term recreational needs of the Borough.
- D. Recommending, in writing, to the Mayor and Council for approval, the hiring of such counselors, supervisors, play leaders, instructors and other personnel as the Council may from time to time deem appropriate.
- E. Attending all meetings of the Recreation Committee.
- F. Providing monthly reports, in writing, to the Borough Administrator and Council liaison detailing such information, including but not limited to revenues, expenditures, program attendance, upcoming programs, and any staffing recommendations for upcoming programs.
- G. Attending meetings of the Mayor and Council upon request.
- H. In conjunction with the Recreation Committee, providing an annual report to the Mayor and Council, no later than December 31 of each year, containing a comprehensive and detailed report covering operations, receipts, disbursements and expenditures for the full year, including a shortand long-term plan for the Recreation Department.

Article II. Recreation Committee

§ 90B-6. Creation.

There is hereby created in the Borough of Montvale a Recreation Committee.

§ 90B-7. Composition; terms of office.

The Recreation Committee shall consist of such members as shall be appointed by the Mayor, along with the Recreation Director. However, the Recreation Committee shall consist of no fewer than five members, exclusive of the Recreation Director. Each member of the Recreation Committee shall be an annual appointment. A member of the Borough Council shall serve as liaison to the Recreation Committee but shall not be a member of said Committee.

§ 90B-8. Organization.

- A. The Recreation Committee shall select from among its members one individual to serve as Chairperson of the Board. The Chairperson, in the absence of the Recreation Director, shall preside over all meetings of the Recreation Committee.
- B. The Recreation Committee may also appoint a Vice Chairperson to serve in his/her absence.

§90B-9. Purpose; duties; responsibilities.

A. The purpose of the Recreation Committee is to assist the Recreation Director and the Mayor and Council in administering, planning, supervising and conducting programs and activities of the Borough's public playgrounds, athletic fields, recreation centers and other recreational facilities and any of the properties owned and controlled by the Borough, including, but not limited to, recreational programs, cultural activities, youth programs and the summer camp, subject to formal approval by the Mayor and Council.

- B. The Recreation Committee shall make recommendations to the Mayor and Council regarding recreational programs, personnel and facilities, the development of new initiatives, and the management of existing programs in the Borough of Montvale.
- C. The Recreation Committee shall advise the Recreation Director in the preparation of the annual budget for the Recreation Department.
- D. The Recreation Committee shall maintain communication with, including, but not limited to, recreational quasi-municipal organizations, in order to coordinate the use of facilities and establish consistent policies and cooperation among the various groups.
- E. The Recreation Committee shall advise the Mayor and Council of any opportunities or needs that should be addressed in the area of recreation.
- F. The Recreation Committee shall maintain communication with other municipal bodies, such as the library and the schools, to minimize duplication of efforts and to foster joint programs.
- G. The members of the Recreation Committee are to maintain the ethical standards of the position of trust to which they have been appointed. Any ethical breach or conduct unbecoming of a member of the board shall be reported immediately to the Mayor and Council for appropriate action, including, but not limited to, removal from the Recreation Committee as permitted by law.
- All decisions and/or recommendations made by the Recreation Committee, including whether to offer particular programs, program fees and personnel decisions, are subject to approval by the Mayor and Council.
- $\sqrt{1}$. All individuals over the age of 18 working directly with children are subject to a background check.

§ 90B-10. Studies; recommendations and reports.

- A. The Recreation Committee may make recommendations to the Mayor and Council as to the establishment of any new staff positions it deems necessary for the successful operation of the Borough's recreational programs. The responsibility for the hiring of such employees shall be vested with the Mayor and Borough Council, and any such employees shall be under the immediate supervision of the Recreation Director, who in turn shall be under the supervision of the Borough Administrator.
- B. On or before January 15 of each year, the Recreation Committee, in cooperation with the Recreation Director, shall prepare and submit to the Borough Administrator a proposed budget for the Borough's recreation program. Prior thereto, the Recreation Committee shall obtain and review budget requests from each of the various recreational programs, which shall be used in the budget preparation process. The budgetary requests shall also be submitted to the Borough Administrator for the purpose of substantiating the Recreation Committee's suggested budget.
- C. The Recreation Committee shall also study such matters as may be referred to it by the Mayor and Council and shall report its findings and conclusions thereon, in writing, to the Mayor and Council as soon as reasonably possible.

As of today the Montvale Fire Department has moved out of the old firehouse and have started operating out of the back side of the DPW building as planned. All fire apparatus and fire fighting equipment has been relocated there. Over the next few days we will have all the remaining boxes and incidental stuff removed from the old bldg.

As you can imagine, we are operating in extremely tight quarters, sharing space with the DPW. Getting fire trucks out to calls during critical times such as when school is going in and letting out, baseball games, and in general, traffic on Memorial Drive on any given day, is a condition we would like to get some help with. There are 11 parking spaces in front of the DPW by the red shed. We would like to temporarily make the first 9 spaces a NO PARKING FIRE ZONE until we move back into the new Firehouse so we can swing our Tower Ladder out onto Memorial Drive coming out of the DPW building. Right now if cars are parked there we are not able to get this truck out of the garage safely, or not at all.

This does not effect the drop off of school students in the morning as this area is only a drop off zone at that time and would not prevent us from being able to turn onto Memorial Drive as no cars are allowed to park there then. Other then that time, it would be a NO PARKING FIRE ZONE enforced by our police department. Response now, while the new fire house is being built, means all emergency response traffic will be taking place on Memorial Drive and we want to make it as safe as we can for everyone.
