FIREARMS APPLICATION INSTRUCTION SHEET

THE FOLLOWING PROCEDURE MUST BE FOLLOWED IN ORDER TO PROPERLY PROCESS ALL FIREARMS RELATED APPLICATIONS

- 1. FIREARMS ID CARDS AND HANDGUN PERMIT APPLICATIONS WILL BE PROCESSED ONLINE THROUGH THE **NEW JERSEY STATE POLICE WEBSITE FIREARMS APPLICATION & REGISTRATION SYSTEM**. www.njsp.org/firearms/fars.shtml
- 2. WHEN PROMPTED TO ENTER YOUR **ORI NUMBER**, INPUT **NJ0023600**
- 3. <u>CONCEALED CARRY PERMITS</u> APPLICATIONS WILL BE PROCESSED ONLINE THROUGH THE NEW JERSEY STATE POLICE WEBSITE **APPLICATION & REGISTRATION SYSTEM** https://www.njportal.com/NJSP/ConcealedCarry/
- 4. ALL FORMS MUST BE COMPLETED IN THEIR ENTIRETY. INCOMPLETE OR INCORRECT APPLICATIONS WILL HAVE TO BE RESUBMITTED AND CAUSE A DELAY IN PROCESSING.
- FINGERPRINTING IS NOW PERFORMED BY <u>IdentoGo (MorphTrust)</u>. APPOINTMENTS ARE MADE ONLINE <u>uenroll.identogo.com</u> OR BY TELEPHONE (TOLL FREE 877-503-5981)
 PAYMENT TO <u>MORPHOTRUST</u> IS DUE AT TIME OF SCHEDULING. PROPER IDENTIFICATION IS REQUIRED AT FINGERPRINTING.
